

Delivery/collection at CHEMPARK Leverkusen

Dear customer,

We would like to point out that our laboratories are located on a site belonging to the CHEMPARK. Access to this site is subject to strict safety regulations and rules. These measures are designed to ensure the safety of all visitors and employees and the smooth running of business.

We therefore ask for your understanding that certain rules and regulations must be observed when entering and remaining on the Chemical Park site. This includes carrying valid identification*.

*For the purposes of the CHEMPARK regulations, the following original official documents are considered to be identification documents, unless the personal details contained therein are based on information provided by the holder of the document.

- For **German nationals**, only a valid identity card/official identity card replacement or a valid passport/official passport replacement will be accepted.
- For **nationals of the full Schengen member states**, a valid, officially recognised national identity card corresponding to the German identity card or a valid, officially recognised passport/passport replacement corresponding to the German passport.
- For **nationals of other countries**, this is a valid, officially recognised passport/replacement passport corresponding to the German passport.



Unfortunately, we cannot accept other documents such as a driving licence.



These documents will be required at the gate:

- Original official identification document*.
- Original residence permit and work permit, if applicable
- Pick-up/delivery reference (delivery note, order, etc.)

You need to be able to answer these questions:

- What is your objective at the CHEMPARK?
- What is your job at the CHEMPARK?
- Who is responsible for your work at the CHEMPARK?
- Who is your employer?

You are not allowed to do this:

- Bring along accompanying persons who are not members of the driving personnel.
- Bring tools, materials or IT equipment into the CHEMPARK without registering them.
- Spend the night in a vehicle on the CHEMPARK site.
- Take animals with you

The following applies throughout the CHEMPARK:



30 km/h speed limit



No smoking – even in vehicles



Strict prohibition of alcohol and intoxicants



No photography or filming



Priority for rail traffic



No animals

- **Saturday, Sunday & public holidays (NRW): closed**

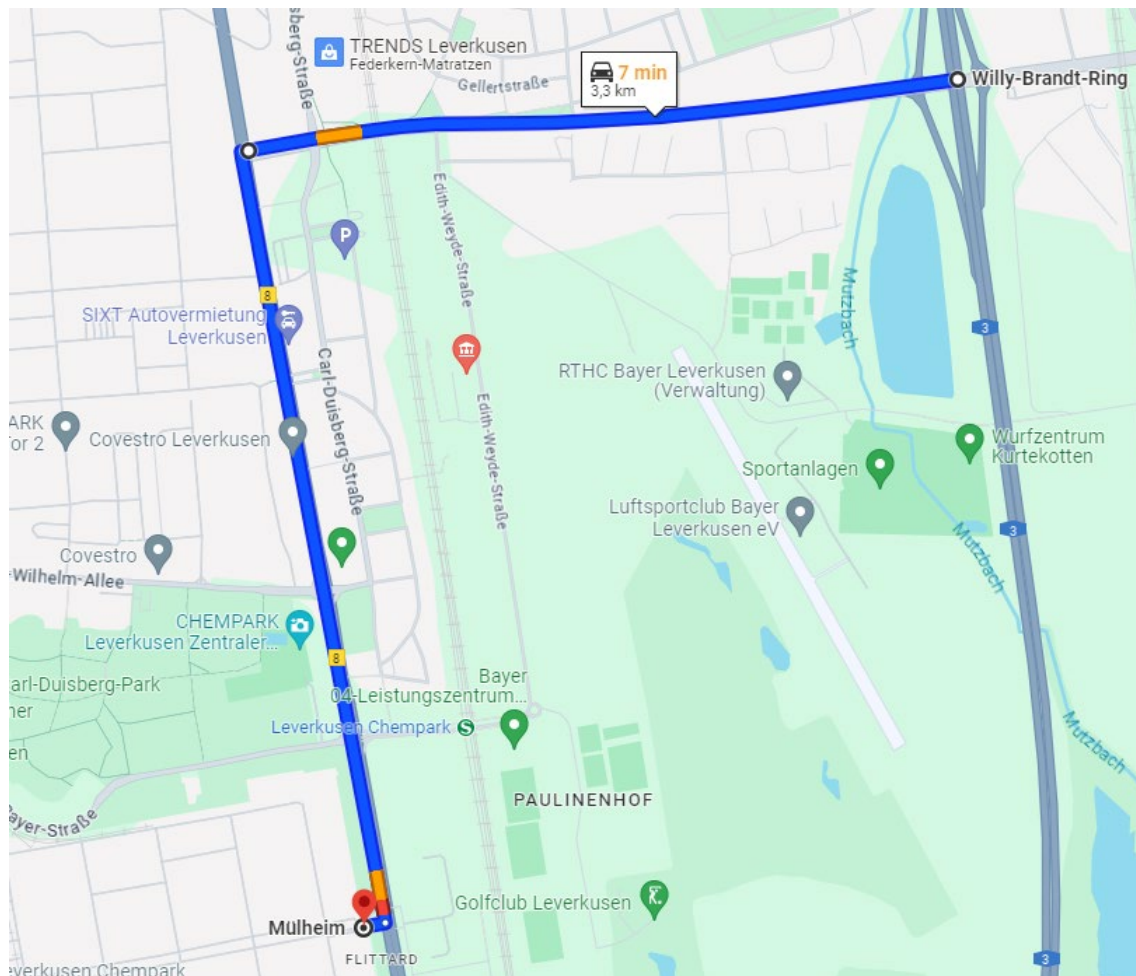
We ask that you submit your samples within these times to ensure smooth processing. If you have any questions or require a special appointment, please do not hesitate to contact us. We are at your disposal.

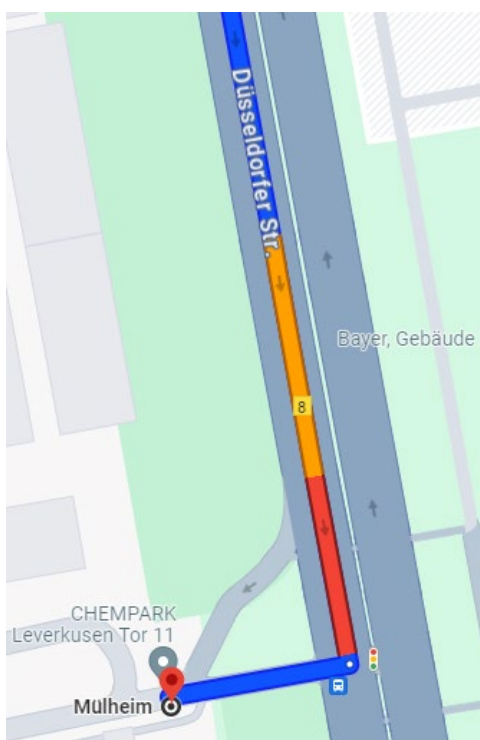
